


Hypo 1 – De Facto Parent & Parentage Equality Act

Maria and Denise were in a 10-year relationship. Denise conceived via assisted reproduction. Maria acted as a parent but never signed a VAP or adopted.

Commonwealth of the Northern Mariana Islands





9 states, 4 territories are uncertain or require parent to provide specific evidence

5 states do not recognize de facto parents (including Illinois)




Civil Contempt of Court

Hypo 2 – Indirect Civil Contempt

James ordered to pay \$500/month in 2019; owes \$20,000. Claims inability but records show vacations, new motorcycle, high end lifestyle.

Hypo 3 – Administrative Review & Voidness

2019 administrative order vs Indiana resident,
who claims no service. 2023 petition to ALJ
denied as untimely under 2-1401 standards.



Hypo 4 – Section 513 in Parentage Case

Angela & Mark never married. Paternity established via VAP. Child enrolls in college. Angela seeks college contribution under §513.





Hypo 5 – Arrearages Post- Emancipation

NCP ordered to pay in 2010. Children emancipated 2020.
2025: \$60,000 arrears + interest.

Hypo 6 – Sovereign Citizen Objection

2024 support case vs Robert. Refuses to appear, sends bizarre “affidavits.” In court, claims:

- Only his “all-caps name” is subject to jurisdiction.
- Statutes apply only to federal employees/DC citizens.
- He repudiated SSN/birth certificate.
- Enforcement = “contractual slavery.”
